Total intake capacity is 25 seats under the Centrally Sponsored PWD Scheme and out of which 15% seats are reserved for the female candidates.

1. The Candidate must be permanent resident of Jammu and Kashmir State.
2. The candidate must have passed Matriculation/Secondary School Examination or any equivalent examination from a recognized statutory Board/University with not less than 37% marks.
3. Candidates must have Disability Certificate from Chairman District medical Board with minimum percentage of Disability 40% or above.

Age: There will be no age bar for admission to diploma Courses in Polytechnics of J&K State

Certificates to be attached (Photo copies duly Attested)

- a. Marks certificate of the qualifying examination (10th Class)
- b. Disability Certificate issued by the competent authority clearly specifying percentage of disability which should be 40% or above bearing proper dispatch number and date of issue.
- c. Permanent Residence Certificate (State Subject)
- d. Category certificate if any.

Note: Under process certificate shall not be entertained

Last date for submission of application forms in this office is Wednesday, the 14th of October 2020 upto 12:00 P.M. Counseling/verification of documents shall be done by the Selection committee on the 14th of October 2020 at 02:00 P.M. sharp.

Selection: The Selection of the Persons With Disability candidates in different disciplines shall be made by the selection Committee constituted for the purpose on the basis of merit of qualifying examination and the stream allocation shall be on the basis of their merit and fitness for a particular stream depending upon the percentage and type of Disability.

Classes: Regular classes of the selected candidates shall start at par with the candidates selected through the Board of Professional Entrance Exam for Academic session 2019-20.


